



## Terms & Conditions

### 1. Quote Validity Period

---

This quote is valid for 30 days from the date of issue. After this period, pricing and availability are subject to change. Pricing from a prior invoice or quote does not guarantee the same pricing on future or reorders.

### 2. Pricing

---

All prices are quoted in USD and are exclusive of any applicable sales, use, excise, import, or other taxes, duties, or government charges. Such taxes will be added to the invoice where applicable.

### 3. Sales Eligibility & Right of Refusal

---

2D DUMMIES products are sold exclusively to verified law enforcement agencies, military and corrections organizations, licensed firearms training professionals, and credentialed public safety entities. 2D DUMMIES reserves the right to verify the credentials and organizational affiliation of any prospective buyer prior to order acceptance, and to decline or cancel any order at its sole discretion.

Submission of a purchase inquiry or payment does not constitute a binding order until explicitly accepted in writing by 2D DUMMIES.

Resale or transfer of 2D DUMMIES products to any party not meeting the eligibility criteria outlined herein is strictly prohibited.

### 4. Payment Terms

---

Payment in full is required at the time of order placement and confirmation, prior to the commencement of production and shipment, unless alternative payment arrangements have been explicitly agreed upon in writing by 2D DUMMIES. Accepted payment methods include ACH/wire transfer, company check, and major credit cards. Payment instructions are provided directly on your invoice. Orders will not be processed until payment is received and cleared.

For orders exceeding \$10,000, a 50% deposit may be accepted at order placement, with the remaining balance due prior to shipment. Failure to remit the remaining balance prior to the scheduled shipment date may result in cancellation of the order. In such cases, the deposit paid shall be forfeited to 2D DUMMIES to cover costs incurred.

### 5. Order Confirmation & Processing

---

Orders are considered confirmed only upon receipt of full payment (or agreed-upon deposit) and written acceptance by 2D DUMMIES. 2D DUMMIES reserves the right to conduct buyer eligibility review following receipt of payment. If an order is declined following payment, a full refund will be issued.

## **6. Lead Time / Delivery**

---

Standard lead time for orders is approximately 1–4 weeks from the date of order confirmation and receipt of payment. Actual delivery dates will be confirmed upon order placement and may vary based on order volume and material availability. Expedited shipping may be available at an additional cost.

## **7. Product Description & Use**

---

The 2D DUMMIES TIM (Threat Identification Manikin) firearms training target is designed exclusively for professional law enforcement, military, corrections, and credentialed public safety firearms training using Non-Lethal Training Ammunition (NLTA), such as Simunition®. Any other use is at the sole risk of the user.

The purchasing organization or individual assumes full responsibility for ensuring that all end users of 2D DUMMIES products are qualified, trained personnel operating within an authorized training program. Misuse, modification, or use with unauthorized ammunition or equipment may void warranties and pose serious safety risks.

## **8. Shipping & Handling**

---

Shipping and handling charges are not included in the quoted price and will be added to the invoice, unless expressly stated as “Free Shipping” on the quote or invoice itself. Products are shipped FOB Origin – Naples, FL. The buyer assumes all risk and responsibility once the shipment leaves 2D DUMMIES’ facility.

## **9. Warranty**

---

2D DUMMIES warrants its products against defects in materials and workmanship for a period of 6 months from the date of purchase. In the event of a valid warranty claim, 2D DUMMIES will, at its sole discretion, repair, replace, or refund the defective product.

This warranty does not cover normal wear and tear, cosmetic damage, or any damage resulting from misuse, improper storage, unauthorized modifications, or use with ammunition or equipment other than what is explicitly recommended for the product.

## **10. Limitation of Liability**

To the maximum extent permitted by applicable law, 2D DUMMIES’ total liability to the buyer for any claim arising out of or related to the sale or use of its products shall not exceed the total purchase price paid by the buyer for the specific product giving rise to the claim.
